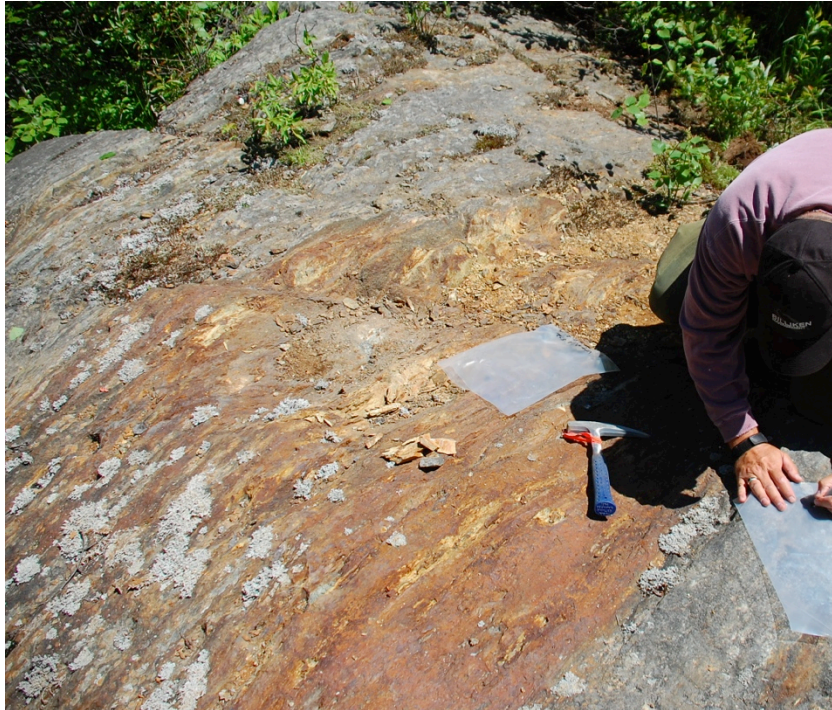


## Renforth Discovers Gold in Outcrop in the Exploration Target Area on the New Alger Property

**Toronto, Ontario, June 27, 2013** – Renforth Resources Inc. (“**Renforth**” or the “**Company**”) (CNSX:RFR) is pleased to announce that the Company has completed a reconnaissance visit to its New Alger Property (the “Property”), located approximately 20 km west of Malartic, Quebec . The Property lies astride the Cadillac Break, a major gold bearing deformation zone within the Abitibi Mineral belt which has produced over 100 mines and 170 million ounces of gold since 1901.

The purpose of the site visit was to locate outcrop within the Exploration Target area identified as a result of the major data compilation and model study of the past producing Thompson-Cadillac Mine on the Property. (Reference: Press Release April 12, 2013, “*Renforth Announces Exploration Target for New Alger*”).

The Company reports that during the site visit gold was discovered in outcrop within the Exploration Target area, roughly equidistant between the two capped shafts on the property. Based on observations made by management and Mr. Brian H. Newton, P. Geo, the Company believes the outcrop represents the southern contact boundary area of the Cadillac Break.



During the Property visit four grab samples were selected, each of these returned gold values, with the best result being 0.72 g/t Au from the sample taken in the picture above, an outcrop of sheared silicified sediment which contains sulphide mineralization presenting as clots of massive and disseminated pyrite.

Nicole Brewster, President and CEO of the Company participated on the site visit and reports “The discovery of gold-bearing mineralization at surface is quite exciting to the Company. Summer 2013 plans, prior to the reconnaissance visit, had been for a surface mapping, prospecting and sampling campaign. This discovery highlights the need for this sort of work at New Alger”.

Mr. Brian H. Newton P. Geo is a “Qualified Person” pursuant to the requirements of National Instrument 43-101 and has reviewed and approved the contents of this press release. Samples were bagged and securely sealed in the field. The samples were couriered using a bonded carrier to Activation Laboratories in Ancaster, Ontario where they were subjected to Fire Assay with Atomic Absorption for gold.
